Public forum-BCBI The chair outlined the procedures for addressing the board and invited any member of the audience to come forward.

Lancaster High senior Brandon Newton addressed the board, urging them to be sure schools don't just focus on teaching the basics needed to pass standardized tests. Brandon stressed that without an effort to foster creativity in students, teaching is not as effective, and he stated that what has made America great is the creativity and innovative approaches its citizen use to address problems. He stated that Lancaster High's recent lipdub was a good example of student creativity and how it can not only be used as a teach-

ing tool, but can also build student morale and get them working together. Brandon also noted that education is the only business that ignores input from its consumers and urged the board to seek input from students on what is and is not working in classes and asked that they find time to meet with student leaders to get that input.
